NOTICE OF CORRECTED CALCULATION OF SEARCH FEES

In the joint status report of the parties filed on January 31, 2003, the United States stated that, since August 2000, it has incurred at least \$29,000.00 in fees in connection with the search for and processing of responsive records to plaintiff's FOIA requests. See January 31, 2003 Joint Report at ¶ 3. To date, plaintiff has not paid any of these search fees. Since the date of the filing of the joint status report, the CIA has reviewed and reconfirmed the calculation of the fees incurred, to date, for the processing of the plaintiff's FOIA requests.

The Government has determined that some of the fees initially attributed to plaintiff's FOIA request have been mistakenly included in the Government's fee calculation. Moreover, although the overall number of hours expended in processing plaintiff's FOIA requests remains unchanged, the Government has determined that the portion of these fees that are attributable to the search for responsive records should be reduced. As a result, the Government advises the Court and plaintiff that the correct amount of fees incurred by the CIA since August 2000 for the search of records responsive to plaintiff's FOIA requests is \$10,906.33.






